Upskilling Course

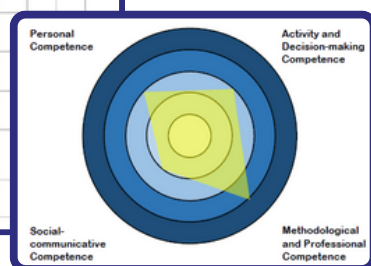
Let's dive into practice. Our childcare professionals are currently developing an Upskilling Course. It aims to provide continuous vocational education, helping other professionals to enhance their competences.

The **Self-Assessment Tool** will help you to check your knowledge, skills and attitudes. You will be assessed in four competences areas and immediately see your results.

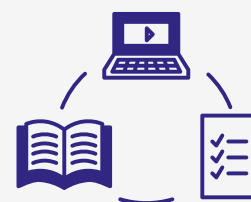
